# 2. CHAIRPERSON'S FOREWORD

In 2022, the IT industry welcomed the lifting of lockdowns and a move to the 'new normal'. In this changed post-pandemic world, digital technologies are the mainstay and foundation for almost every aspect of work, business and daily life. At the same time, certain technologies – including robotics and AI – went from futuristic to mainstream seemingly overnight.

This accelerated digital progress underlined to us the need for urgent efforts to upskill the children and young people of Africa, lest they become 'digitally illiterate' and fall behind the young people of the world in the global digital workplace.

At the same time, the 2022 JCSE – IITPSA ICT Skills Survey revealed that growing numbers of South African employers were recruiting ICT skills overseas and more local practitioners were looking to work for companies abroad. To us, this could signal a widening IT skills gap.

In our public submissions and thought leadership articles in 2022, we focused heavily on the need for all stakeholders across the public and private sector to work together to close the digital divide and upskill our young people to build a pipeline of local skills. Now, more than ever before, digital literacy training, advanced ICT skills development, and the use of ICTs to enhance teaching and learning must be a top priority in all schools across the continent.

The IITPSA's Talent Search and Computer Olympiads are designed to support the development of Science, Technology, Engineering, Mathematics and Innovation (STEMI) skills and interest to equip South Africa's youths for careers in the 4IR. We have stepped up our focus on promoting these activities to increase the number of learners participating.

We also focused on young people through events such as our highly successful Careers in IT webinar, as well as outreach efforts by our Western Cape Chapter, who visited schools to evangelise careers in IT.

In line with our efforts to encourage and develop youth skills, we introduced our Dynamism in ICT youth award. No sooner had we invited nominations for this award then we received numerous nominations for exceptional and driven young candidates. We see this as a sign that the South African IT sector is growing, and is populated by growing numbers of outstanding professionals exemplifying Brilliance in IT.

# 3. CEO'S MESSAGE



2022 marked the IITPSA's 65th anniversary. a significant milestone that underlined our ability to adapt and thrive in an ever-changing environment. From small beginnings as the Computer Society South Africa (CSSA) in 1957, the IITPSA has grown into a professional body representing ICT Professionalism and ethical behaviour, which is trusted at the highest level.

To better reflect our role as a professional body, we changed our name to the Institute of IT Professionals South Africa (IITPSA) in 2011. We were recognised as a Professional Body by SAQA in 2012, accredited by IFIP IP3 in July 2015, and we are SAQA and IFIP IP3 accredited for our professional programmes (Professional Member

and Professional CIO). In October 2022, the IITPSA Board revisited and refined the Institute's Vision as follows: "to be an inclusive community of ICT professionals that leads the promotion and development of a thriving digital society". Over the years, our public profile and stakeholder engagement has grown, and the Institute is now widely recognised as the official voice of South African IT professionals.

Illustrating this, the media regularly asks the IITPSA's opinion on IT industry developments and cites our JCSE - IITPSA IT Skills Survey as the credible source of skills information in our sector. Adrian Schofield, the co-author of the survey, is widely regarded as an IT skills expert and was asked to speak at SAQA's professional body forum. We partner with leading industry events and increasingly collaborate with broader industry bodies, and also signed an MoU with the City of Johannesburg Department of Economic Development in May of 2022 to collaborate on ICT sector development and digital skills development initiatives. We have also engaged with the Gauteng Government on an integrity pledge on ethics.

In 2022, we resumed and increased our activities as the pandemic abated and lockdowns were eased. Recognising the popularity of the webinars and online forums we introduced during the lockdown, we opted to continue hosting online gatherings in addition to face-to-face events. This has enabled us to expand our reach and engage with experts from across the continent and around the world. Our annual IITPSA President's Awards continue to recognise excellence and professionalism in ICT throughout the SA Economy, and, as the Board Chairperson noted in his foreword above, in 2022, we introduced the new "Dynamism in ICT Youth Award" to recognise the amazing potential and achievements of the more recent entrants to the South African ICT profession and industry.

We are exceptionally proud of our progress over the past 65 years, and the role we continue to play in representing our IT professionals and encouraging professional development and early IT skills development.

We thank all our members and associates for their ongoing contributions to our growth and development.




# 4. MEMBERSHIP


# **TOTAL MEMBERSHIP**









The audit and risk committee operates within documented terms of reference and adheres to relevant legislation, regulation, and governance codes, with the committee's report presented to members in compliance with the Companies Act and King IV.

The committee has an independent role with accountability to both the board and members, with responsibilities including statutory duties, activities recommended by King IV, and additional responsibilities assigned by the board.

### **ROLE OF THE COMMITTEE**

### **ANNUAL REPORTING**

Review and approve the annual financial statements, accounting policies, and disclosure policies, and evaluate the effectiveness of internal financial controls.

Perform an oversight role on the Institute's annual reporting, including sustainability disclosure, and consider factors and risks that could impact the integrity of the annual report.

Recommend the annual report for approval by the board.

### **COMBINED ASSURANCE**

Ensure the combined assurance model addresses all significant risks facing the Institute and monitor the relationship between external and internal assurance providers and the Institute.

### **FINANCE FUNCTION**

Evaluate the expertise and resources of the finance manager and the Institute's finance function.

### **RISK MANAGEMENT**

Make recommendations to the board on levels of risk tolerance and appetite, and ensure risk management is integrated into business operations.

Ensure risk management assessments are conducted on a continuous basis, frameworks and methodologies are implemented to anticipate unpredictable risks, and appropriate risk responses are implemented. Express the committee's opinion on the effectiveness of the system and process of risk management, and ensure comprehensive and relevant risk management reporting in the annual report.

### **EXTERNAL AUDIT**

Review the quality and effectiveness of the external audit process, and ensure the committee is informed of any reportable irregularities identified by the external auditor.



### **CONTROLS AND AUDIT**

### **INTERNAL CONTROL**

Systems of internal control are designed to manage, rather than eliminate, the risk of failure to achieve business objectives and to provide reasonable, but not absolute, assurance against misstatement or loss.

While the board is responsible for the internal control systems and for reviewing their effectiveness, responsibility for their actual implementation and maintenance rests with executive management. The systems of internal control are based on established organisational structures, together with written policies and procedures, and provide for suitably qualified employees, segregation of duties, clearly defined lines of authority and accountability. They also include cost and budgeting controls, and comprehensive management reporting.

### **INTERNAL FINANCIAL CONTROLS**

The committee has assessed information and explanations given by management on the results of the 2022/23 audit. Through this process no material matter has come to the attention of the audit and risk committee or the board that has caused the directors to believe that the company's system of internal controls and risk management is not effective and that the internal financial controls do not form a sound basis for the preparation of reliable financial statements.

### **EXTERNAL AUDIT**

The external auditor has unrestricted access to the Institute's records and management. The auditor furnishes a written report on significant findings arising from the annual audit.

The audit partner in charge of the audit is rotated off the audit after five years. In terms of this policy, the current audit partner is in the first year of tenure. The Institute has received confirmation from the external auditor that the partners and staff responsible for the audit comply with all legal and professional requirements with regard to rotation and independence. The committee is satisfied that the external auditor is independent of the company.

# EVALUATION OF FINANCE MANAGER AND FINANCE FUNCTION

- The committee is satisfied with the expertise and experience of the finance manager to meet the responsibilities of the position, based on qualifications, experience, and professional education, as well as the board's assessment of the finance manager's financial knowledge.

The Social & Ethics Committee is a crucial part of IITPSA's governance structure. While not mandated by law, IITPSA recognises the importance of the committee in the communities and environment where it operates and pursues its business goals. The committee serves a vital monitoring and strategic role in line with the increased global focus on integrating Environment, Society, and Governance (ESG) considerations into organisational strategies and are guided by the Board approved Terms of Reference. IITPSA's Code of Ethics is used as the foundation of ethical decision making.

According to the Social & Ethics Committee Terms of Reference the committee consists of at least three (non-executive) directors and an additional two IITPSA members may be appointed by the Board. The committee chairperson should be a non-executive director.

Non-executive directors Mr Kudzayi Chipidza, Ms Pearl Pasi and Ms Josine Overdevest have been members of the Social & Ethics Committee for the duration of the reporting year. Ms Josine Overdevest was re-elected as chairperson during the August 2022 Board meeting. During this Board meeting Ms Senele Goba resigned from the committee and Prof Lynn Futcher was elected as new non-executive director in the committee. Since June 2022, Mr Constandious Takura Munakandafa brings his expertise and experience to the Social & Ethics Committee as a voluntary IITPSA member.

### THE FUNCTION AND WORK OF THE COMMITTEE CAN BE SUMMARISED AS FOLLOWS

- Monitoring activities related to good corporate citizenship, including promotion of equality, prevention of unfair discrimination, reducing corruption in society, contribution to community development, recording of sponsorship, donations, and charitable giving, and ensuring compliance with consumer protection laws.
- Monitoring activities related to the environment, health, and public safety.
- Monitoring activities related to member and stakeholder relationships, including advertising and public relations.
- Monitoring activities related to labor and employment, such as the organisation's standing on the International Labor Organization Protocol on decent work and working conditions.
- Monitoring social and economic development activities based on IITPSA's standing in terms of the goals and purposes of the United Nations Global Compact, OECD recommendations regarding corruption, the Employment Equity Act, and the Broad-Based Black Economic Empowerment Act.
- Oversight responsibilities, which include maintaining oversight of corporate citizenship activities, environment, health and public safety, stakeholder relationships, labour and employment, ethics governance, procurement processes, and membership matters including:
  - i. Reviewing members' complaints and compliments and providing guidance on what is working well and what needs to change.
  - ii. Handling applicant grievances:
    - Prospective members who are not accepted follow a process where they can question why they were not accepted.
    - If the process has been exhausted, the applicant can escalate the matter to the SEC as a last resort.
    - The SEC will review decisions taken throughout the process.

### **COMMITTEE WORK IN PROGRESS**

### • Meetings

We hold four online meetings annually. IITPSA senior management attends by invitation. Any conflicts are adjudicated by the IITPSA Board.

### Implementation of the IITPSA Code of Ethics

Our current work is the implementation of the IITPSA Code of Ethics and Code of Good Practice amongst the IITPSA members with a focus on professional pride, integrity and reputation. In webinars and contributions to the IITPSA newsletter and social media we explore how ethics play an increasingly important role in the IT profession and explain how members can use an ethical decision-making model in their daily IT practice.

In August 2022 we hosted a webinar with Dr Paul Vorster from The Ethics Institute who provided a general understanding of ethics. During the 25 October 2022 webinar we discussed the role that African philosophers have to play to include African values in the global AI ethics discourse with Arthur Gwagwa, a doctoral researcher at the Utrecht University Ethics Institute.

The Members' Council acts as a platform for Chapter Chairs to interact with each other, share valuable insights, and deliberate on issues of common concern. This is also the channel for the Chapter / SIG Chairs to put forward to the IITPSA Board challenges, opportunities and recommendations regarding membership matters and activities at Chapter / SIG level.

Following a Members' Council decision on 03 November 2022, allowing the Chairpersons of "National" Special Interests Groups to join the Members' Council, the Chairperson of the Cybersecurity Special Interest Group (SIGCyber) was invited to join the Members' Council.

The IITPSA CEO presides over the Council, reports on its activities to the Board, and ensures its smooth functioning. The Members' Council convenes quarterly, two to three weeks before each Board meeting.

We express our gratitude for the dedication, expertise, and hard work of our entire team. Together, we strive to achieve our goals and provide exceptional value to our stakeholders and members.




# **6. ACTIVITIES**

# 6.1 IITPSA EVENTS HIGHLIGHTS 2022/23

### **AFRICA OUTREACH**

The IITPSA believes pan-African IT industry collaboration and knowledge sharing is beneficial for all parties, and as such, has focused on building relationships across the continent. IITPSA is a member of IFIP and AfICTA and is making inroads into the development of a new Confederation of African Computer and Information Technology Societies (CACITS). Over 20 African countries have expressed interest to date.

### 2022 JCSE-IITPSA SKILLS SURVEY

The 2022 JCSE-IITPSA ICT Skills Survey Report was released in October, providing valuable insights for industry practitioners and media. The study found that there was a significant increase in South African employers recruiting ICT skills overseas, and more practitioners looking to work for companies abroad. Additionally, the survey found that the number of enterprises struggling to recruit critical IT skills had increased from 20% to 35%. The report also highlighted that the average South African ICT practitioner performs multiple task sets, with only a few considering their roles as "specialist." Despite the COVID-19 pandemic leading to some contraction in the sector, demand for skills still exceeded supply in many categories.

The report was authored by Adrian Schofield, Production Consultant at IITPSA and Emeritus Professor Barry Dwolatzky from WITS University, with platform support from Eduflex.

### **PROFESSIONAL DESIGNATIONS**

The IITPSA has continued to add to the number of members achieving the Professional Member grade and designation (PMIITPSA®) and introduced the broader-based certification of membership at SFIA level 3 and above, with the designation of Certified member (CMIITPSA). In February 2022, the Pr.CIO® designation was approved as a professional registration by SAQA, and exclusive Pr.CIO round table events were launched. The Pr.CIO designation is awarded only to South African CIOs who have met global standards for competence, ethical issues, social implications, legal considerations, and have the required skills and experience. It is IFIP IP3 accredited at SFIA level 7.



### **ONGOING ENGAGEMENT**

During 2022, we achieved strong growth and expansion of stakeholder engagement in several of our chapter and Special Interest Group online events hosted by the SIGCyber, SIGAIR (AI & Robotics), SIGIST (Software Testing), and Blockchain SIGs and the Social & Ethics committee. Our webinars and online forums were stepped up to cover a growing number of topics, so that IT professionals across the country could benefit from connecting with their peers.

In addition, our regional chapters returned to hosting in-person events after a two-year hiatus. IITPSA also partnered with several leading industry events, where we took the opportunity to reconnect with the sector after the lockdowns.

### **IFIP IP3 ACTIVITY**

Moira de Roche continues to serve as Chair of the IP3 Board and Adrian Schofield heads the IP3 Standards and Accreditation Council. IP3 has completed the accreditation of Computer Society of Sri Lanka's professional member scheme and the re-accreditation of the Canadian Information Processing Society and Australian Computer Society schemes.

# **6.2 IITPSA Presidents Awards**

The 2021 IITPSA President's Awards winners, with the awards themed "Excellence in the New Normal", were announced in April 2022. The 2022 awards ceremony, themed "Celebrating Brilliance in ICT", and aligned to the IITPSA's 65th (Sapphire) anniversary, was held in November 2022 at a gala breakfast event, with a new Dynamism in ICT youth award introduced.

For the first time, the IITPSA observed a 50-50 split between male and female finalists, which is viewed as an encouraging sign of progress towards closing the gender gap in the industry.

# **6.3 COMPUTER OLYMPIADS**

### COMPUTER OLYMPIADS AND TALENT SEARCH

The IITPSA hosts various annual skills development activities, including the SA Computer Olympiads and Talent Search. These events were held in-person in 2022 and were successful, with some participants becoming "repeat stars." Approximately 17 000 learners from some 190 schools across the country participated in the 2022 Talent Search.

The SA Computer Olympiads consist of three school-based contests, namely, the Talent Search, the Applications Olympiad and the Programming Olympiad. Top performers from the Computer Programming Olympiad make up the national team that participates in the International Olympiad in Informatics (IOI).

A South African team, selected from top performers in the South African Computer Programming Olympiad held in 2021, participated in the International Olympiad in Informatics (IOI) 2022, held in August in Yogyakarta, Indonesia, with support and coaching from IITPSA members.



The team consisted of four members from various schools and was led by Taariq Mowzer from the University of Cape Town, with Kamohelo Motloung, IITPSA's Education Officer, as the deputy team leader. Minkyum Kim earned an IOI bronze medal at the event.  $(\bigcirc$ 



### TALENT SEARCH

Talent Search aims to identify learners with an aptitude for IT, encourage them to consider a career in IT or to take suitable subjects for a career in IT and to develop problem-solving.

In 2022, a total of 17,114 learners from 190 schools participated in the Talent Search, reflecting a significant increase from the previous year's figures by over 4,500 entrants. This rise in participation suggests a positive upward trend.

### **APPLICATIONS OLYMPIAD**

The Applications Olympiad aims to identify, encourage and reward computer application skills, to promote and encourage the study of the school subject Computer Applications Technology (CAT) and to create an awareness of study and employment opportunities in the field of Information and Communications Technology (ICT).

Since 2010 the subject "Computer Applications Technology" (CAT) has been offered up to grade 12 at both state and independent schools. Typically, ten times more learners take CAT than those who take the subject Information Technology (programming). Many schools, including primary schools, offer some form of digital literacy in addition to the prescribed curriculum.

The number of learners who participated went up again, from 3578 to 4387 and the number of schools from 231 to 260.

### The 2022 Applications Olympiad invited 13 Finalists to take part in the finals.

The Awards Function was hosted at Waterkloof Pretoria. The guest speakers were IITPSA President, Admire Gwanzura and CEO, Tony Parry. Among the guests were Finalists, Parents, Teachers, Computer Olympiad Trustees, Scientific Committee members and Officials from various provinces. Mr Gwanzura (Chair of the IITPSA board) handed over the prestigious IITPSA trophy and the gold medal to the Applications Olympiad winner, Ruan Schoeman.

### **PROGRAMMING OLYMPIAD**

The Programming Olympiad aims to identify, encourage and reward programming skills, to promote and encourage the study of programming, to create an awareness of study and employment opportunities.

### The 2022 Programming Olympiad invited 13 Finalists to take part in the finals.

The IITPSA Floating Trophy for the 2022 SA Programming Olympiad and the gold medal were awarded to Benjamin Kleyn at The Venue on Par in Wynberg, Western Cape, by Mr Admire Gwanzura, Chairman of the board of the Institute of IT Professionals of South Africa.

### THE INTERNATIONAL OLYMPIAD IN INFORMATICS (IOI)

The aim of the International Olympiad in Informatics (IOI) is to promote computer science education worldwide by providing a platform for young students to showcase their problem-solving abilities in computer programming. It encourages the development of creativity, teamwork, and cultural exchange among students from different countries, and serves as a means to identify and nurture future leaders in the field of computer science.

### PARTICIPATION

The 10 top achievers from the previous year's Computer Programming Olympiad are invited to take part in IOI training camps, where a final team of 4, plus 1 reserve, is selected to represent the IITPSA and South Africa at the IOI.

Minkyum Kim earned a bronze medal for South Africa in 2022, obtaining a high score in the bronze range. Thus, South Africa has maintained its IOI standing among all participating countries with an average of very close to two medals per year (60 medals) in its 31 years of participation.

The Internet Service Providers Association (ISPA) kindly sponsored the IITPSA for an amount of R145 000.00 excluding VAT, for the 2022 Programming Olympiad.

# 6.4 BURSARIES AND SCHOLARSHIPS

Over the past few years, IITPSA has been making available a limited number of scholarships and bursaries for young learners and students to study in the field of Information and Communications Technologies.

Scholarship Learners (from Grades 10 to 12) are able to register for an online programme in the school subject "Information Technology" (IT), and are financially supported by the Institute to do this.

The IITPSA and Women in IT Bursaries enable two university level students per year to undertake a relevant, ICT related qualification. IITPSA is delighted to announce that our very first successful bursary graduate (who was also a successful IITPSA IT Scholarship recipient), Ms. Veda October, qualified with a Bachelor of Science in Information Technology degree from Eduvos at the end of 2022. # 7.6 SPECIAL INTEREST GROUPS

The SIG recognised the agony of the crypto bear market and the last presentation of 2022 covered this topic and gave people deep insight into the lessons learnt from this difficult trading environment.

- 1. Blockchain Africa 2022 Report Back was presented via WebinarJam on 29 March 2022. This event summarized all the interesting presentations from Blockchain Africa 2022.

# 7.6.6 CyberSecurity Special Interest Group (SIGCyber)

Cybersecurity threats are constantly evolving, so it's important for organisations to stay aware of the latest developments and implement appropriate security measures to protect their networks and data.

The SIGCyber is an IITPSA Special Interest group (SIG) in South Africa for Cybersecurity and related communities. The purpose of the SIGCyber is to bring together people from diverse backgrounds who are either practitioners, academics or interested in Cybersecurity. The Cybersecurity domain encompasses technologies, policies, procedures, practices designed to protect organisations, institutions and citizens from attacks.

### The objectives of the group are:

- To promote an understanding of the Cybersecurity domain and the nature of the threats which we are facing
- To promote knowledge sharing of the measures to protect organisations and individual
- To raise awareness around the issues relating to Cybersecurity
- To encourage research in the Cybersecurity domain

### WHAT WOULD YOU LIKE TO SEE SIGCYBER DOING IN THE NEW YEAR?

**(KLT)** Increased engagement with the broader community to raise cybersecurity awareness. **(LF)** Regular SIGCyber column in IITPSA monthly newsletter.

# WHAT MAJOR ISSUES DO YOU SEE FACING THE LOCAL CYBERSECURITY COMMUNITY IN THE NEXT 12 MONTHS?

**(KLT)** As technologies such as IoT, blockchain and cloud become more widely utilised, new and increased cybersecurity risks will be realised. More sophisticated and targeted attacks by organised cybercriminals.

**(LF)** Cybersecurity skills shortage, effective cybersecurity and cybersafety awareness programmes, ChatGPT and other AI tools (specifically in academia). Potential impact on cybersecurity also not known.

Cybercrime is now affecting South African businesses, organizations, and critical infrastructure. With global damages estimated to be 6 trillion USD in 2021 and predicted to grow by 15% annually to 10.5 trillion USD by 2025, urgent action is needed. Cyber-attacks can result in business disruption, reputational damage, and legal liabilities. The maximum penalties for serious offenses from the information regulator are a fine of up to R 10M, imprisonment for up to 10 years, or both. South Africa has the third-highest number of cybercrime victims worldwide, costing approximately R 2.2 billion annually. Educating IITPSA members on cyber threats can make a difference in their communities, and providing relevant thought leadership can increase the organisation's relevance in the long term.

# 8. STAKEHOLDER COMMUNICATION AND ENGAGEMENT

As a recognised professional body for ICT practitioners in South Africa, IITPSA is involved in and actively engaged with the wider ICT community, forming appropriate professional relationships with organisations in the public, private, and non-profit sectors. In terms of other professional bodies, IITPSA has relationships with ISACA South Africa Chapter, ISC<sup>2</sup> Gauteng Chapter, SAIEE, and the BRM Institute.

The institute is a member of various organizations, including the SA Independent Professional Bodies Forum, IFIP, AfICTA, and FEAPO. IITPSA has Board level representation on the CIO Council of South Africa, AfiCTA, and IFIP IP3, and is represented on the international council of the Skills Framework for the Information Age (SFIA).

The institute has signed memoranda of understanding with BPESA, Datasec, Coder/LevelUP, and GIBS.

### ENTELECT

During the second quarter of 2022, the IITPSA successfully partnered with Entelect, a corporate company based in Johannesburg, for the benefit of its members. The event was called the IITPSA/ Entelect Hackathon 2022 and took place on April 23, 2022. Following the success of the hackathon, IITPSA and Entelect signed a three-year memorandum of understanding during the third quarter of 2022 to continue hosting the event until 2025.

### **MOUs AND MARKETING AGREEMENTS**

In 2022 renewal of MOUs for ISACA, SAIEE and ISC2 was also a project for the Business Development department. The IITPSA Board approved all three MOUs by the 3rd quarter.
